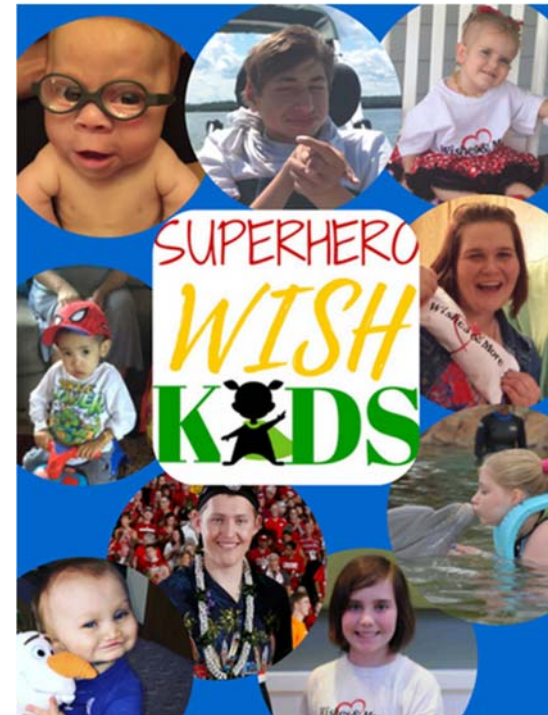

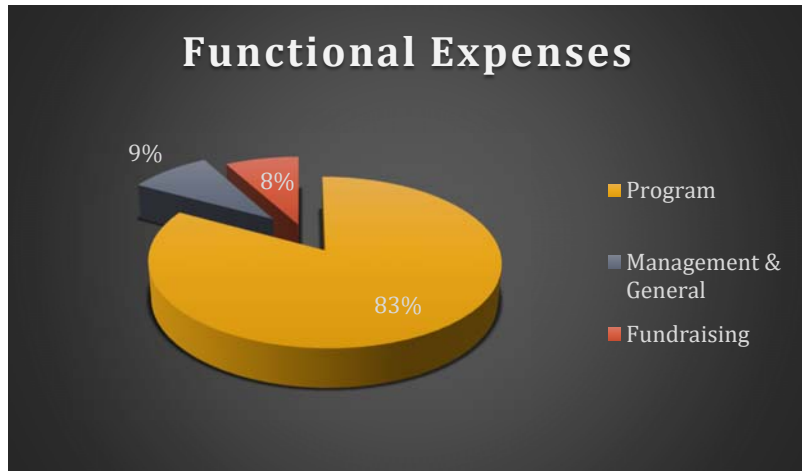

# Organization Overview

## Mission



**Wishes & More**® enhances the life of a child fighting a terminal or life-threatening condition by providing extraordinary experiences... and more.

## Purpose



The purpose of **Wishes & More** is to grant the wish of a child between birth and nineteen who has a terminal or life-threatening condition which will require ongoing treatment and to provide a **Scholarship of Hope**® to be used for higher education: or to give a memorial to the family in the event the child does not survive to have his/her wish fulfilled.

## Population Served



**Wishes & More** serves all children who apply prior to their 19<sup>th</sup> birthday and have a physician's qualifying statement attesting to the child's life-threatening condition requiring ongoing treatment.

Wishes are granted to children living in Minnesota, or who live in the border states of; North Dakota, South Dakota, Iowa, and Wisconsin. **Wishes & More** also extends services to those receiving ongoing treatment in a Minnesota medical facility.

# Unique Programming

Besides granting wishes to these special children who are fighting terminal or life-threatening conditions, **Wishes & More** goes beyond the wish. **More is...**

## Scholarship of Hope®

Upon being granted their wish, each wish child will be presented with a scholarship certificate that will be redeemable as a \$1,000 financial grant to apply to any higher institution of learning beyond high school.

## Memorial Grants

Sadly, not all of the eligible children are able to experience a wish. In this unfortunate situation, **Wishes & More** will give a monetary gift to the family to use at their discretion.

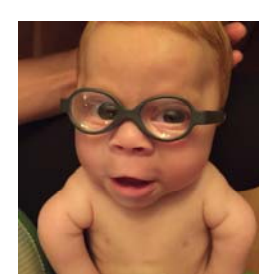
