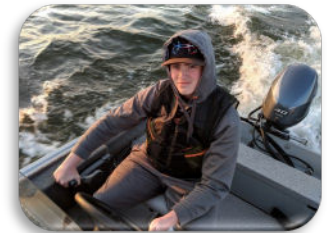

Organization Overview

Mission Statement



Wishes & More enhances the life of a child fighting a terminal or life-threatening condition by providing extraordinary experiences... and more.

Purpose



The purpose of Wishes & More is to grant the heartfelt wish of a child between birth and nineteen who has a terminal or life-threatening condition and to provide a Scholarship of Hope[®] to be used for higher education; or to give a memorial financial gift to the family in the event the child does not survive to experience the joy of a wish.

Population Served



Wishes & More serves all children who apply prior to their 19th birthday and have a physician's qualifying statement attesting to the child's life-threatening condition requiring ongoing treatment. Services are provided to children living in Minnesota; or who live in the border states of North Dakota, South Dakota, Iowa, and Wisconsin; or are receiving ongoing treatment in a Minnesota medical facility.

Programming

Our Tri-fold mission encompasses the emotional and financial impact having a child with a serious medical condition has on our families. We strive to provide uplifting and forward-thinking opportunities to keep kids focusing on the positive; and we also provide our humble comfort along with financial support to grieving families. The significance of our programming is felt in the smiles, the hugs, the notes, and the involvement from families whom we've served since 2005.

Wishes (for kids from infancy – teenage years)

Wishes & More grants wishes to children, ages birth-19, fighting a terminal or life-threatening condition. Our goal is to provide each individual child with their special individual wish. These wishes provide a hopeful anticipation, an extraordinary experience and a beautiful memory for an entire family to enjoy!

Scholarship of Hope®

Upon being granted their wish, each wish child will be presented with a scholarship certificate that will be redeemable as a \$2,000 financial grant to apply to any higher institution of learning beyond high school. These scholarships provide a positive push for kids to think about their future and not just the "here and now" of their condition. They allow kids to receive accolades and financial support, when academic & athletic scholarships have been put out of reach due to illness, and treatments took them out of school. The only qualification for our kids to receive their Scholarship is to enroll in higher education – we not only want them to survive...we want them to thrive!

Memorial Grants

Sadly, not all of the eligible children are able to experience a wish. In this heartbreaking situation, Wishes & More will give a monetary gift to the family to use at their discretion. Our memorial funds are often given directly to funeral homes in order to pay for final arrangements. These funds are meant to be used at the family's discretion in order to use it in whatever way they choose; however, the most heartbreaking is when the funeral home receives the check directly from us.

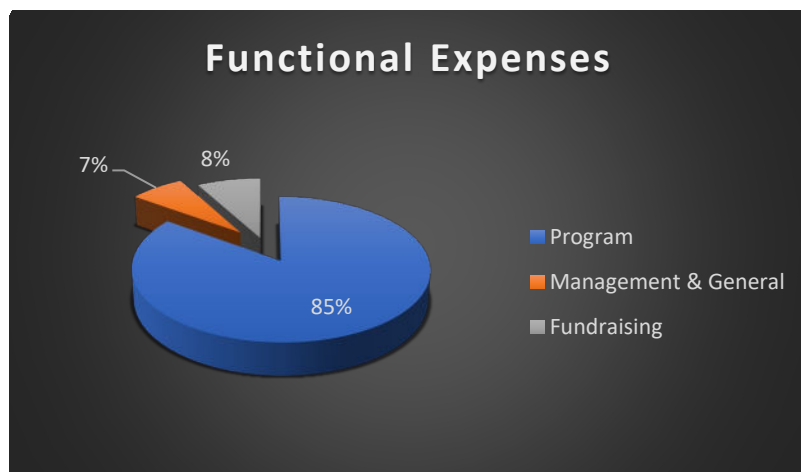
Above & Beyond
