Organization Overview



Mission Statement

Wishes & More enhances the life of a child fighting a terminal or life-threatening condition by providing extraordinary experiences... and more.

Purpose

The purpose of Wishes & More is to grant the heartfelt wish of a child between birth and nineteen who has a terminal or life-threatening condition and to provide a Scholarship of Hope® to be used for higher education; or to give a memorial financial gift to the family in the event the child does not survive to experience the joy of a wish.





Population Served

Wishes & More serves all children who apply prior to their 19th birthday and have a physician's qualifying statement attesting to the child's life-threatening condition requiring ongoing treatment. In 2020, Wishes & More served kids who live in Minnesota or who are treated in a Minnesota hospital.

Programming

The programming of Wishes & More is tri-fold; however, each program provides emotional and financial support to families who have a child battling a critical medical condition. Our goal is to bring each family an uplift & joy-filled wish and scholarship opportunity to allow our kids to focus on positive outcomes; and to provide comfort along with financial support to grieving families whose child didn't survive to experience a wish.

Wishes (for kids from infancy – teenage years)

Every child is unique and so is their wish. We strive to make each experience extraordinary and uniquely their own! From the anticipation to the fulfillment to the memory, Wishes & More creates a one-of-a-kind experience for each individual child. In 2020, 52 wishes were granted bringing enjoyment & happiness to each child, sibling, parents and loved-one who were touched by the experiences.

Scholarship of Hope®

Our unique and incredibly impactful Scholarship of Hope® program is focused on supporting our extraordinary wish kids who have overcome or who may still be battling their condition - but kept their focus on the future! Any previous wish child who attends an accredited higher education institution will receive support from Wishes & More through our Scholarship of Hope® program. We set aside a \$2,000 Scholarship of Hope for each of our wish kids, which may be redeemed at enrollment to any accredited educational program. This program is unique in that funding is not based on academic or athletic prowess; but simply based on surviving a serious, life-threatening diagnosis.

Memorial Grants

Our third program is also unique to Wishes & More. We provide a monetary gift to the parents of a child who does not survive to have their wish fulfilled. For some, these quick and easily attainable funds are desperately needed to proceed with final arrangements; for others, these funds allow for a purchase of a monument that would not be otherwise attainable; and for some, these funds are representative of a community that cares and that, in itself, is meaningful. We encourage the recipients to use funds at their discretion.
